Welcome & Introductions

Mark called the meeting that took place in the Essex Company Stable to order at 10:05 AM. He welcomed guests and thanked LHC board, staff, and volunteers for their efforts across the last year.

a. Approval of the Minutes, September 24, 2022

The minutes from the meeting on September 24, 2022 were unanimously approved, with no opposition.

C. Approval of FY2023 Treasurer's Report Mark Svendsen, Treasurer Mark presented the Fy2023 Treasurer's Report for acceptance. His overview included a summary of our revenue and other support, in addition to our expenses and investment account balance.

The FY2023 Treasurer's Report was unanimously approved, with no opposition.

D. Bylaws Revision

Mark explained the following revision to the LHC Bylaws that will allow us to stagger terms so that no more than one third of the board terms are set to expire in the same year (change in RED).

Section 4.4 - Terms of Office

The first Board of Directors shall consist of those persons named in the Articles of Incorporation. Thereafter, election of Board members shall occur at each annual meeting of the membership. The terms of board members shall be staggered. Thereafter, Board members shall serve three-year terms with approximately one-fourth third of the Board members elected at each annual meeting. Term length may be changed to one-year or two-year terms for new or renewing board members if more than a third of the board terms are set to expire in the same year. Each board member shall hold office until the annual meeting when his/her term expires and/or until his/her

successor has been elected and qualified. Board members may serve a maximum of four (4) consecutive terms.

The Bylaws Revision was unanimously approved, with no opposition.
